"I have the privilege and honor of serving as your current elected ANA Representative to the Membership Assembly. Prior to this position, I served as an expert panel member of the Diversity, Equity, and Inclusion Committee during its inception, and before that participated in the Membership Committee with a focus on growth."

Describe any prior active involvement or participation with ANA (national level).

My most recent involvement and participation with ANA as at the national level has been serving as a voting Representative at the Membership Assembly in Washington DC on June 16-17, 2023. One of the key responsibilities of the ANA Membership Assembly is to determine policies and positions for the Association. I participated in the dialogue forum in which reports on critical healthcare issues were presented to the Membership Assembly, including presentations by the Professional Policy Committee on "Virtual Nursing as a Practice Model Innovation", "The Role of Nursing in Promoting Gun Safety and Preventing Violence", and "Addressing Nursing Documentation during a Time of Crisis

A collaborative discussion on each of these topics occurred following each presentation. The innovative and collaborative efforts that were deliberated on regarding each of these topics demonstrated diverse backgrounds, and expertise that registered nurses across the nation.

The Membership Assembly then voted on the proposed amendments to the bylaws and voted on the recommendations of the proposed policy creation on the topics reported by the Professional Policy Committee. The seven bylaw amendments, all changes in language and not direct changes to procedures, were all approved by the Membership Assembly.

Describe any prior active involvement or participation with other state nurses associations affiliated with ANA or other nursing organizations at the state or national level (e.g., ISAPN, IANNA, NAHN, AONL).

I am the immediate Past President and current Foundation President of the Illinois Association of School Nurses (IASN), a strong affiliate of ANA- Illinois. IASN promotes wellness and educational success of school communities by supporting, developing, and advocating for professional school nurse leaders. I hold a chair position within the American Public Health Association's Nursing Section (APHA-PHN) and currently am on their social media team and the creative behind their Friday Feature Campaign. I am an active representative of Hispanic nurses on the Nursing Coalition on Climate Change and Health, and a Fellow of the Alliance of Nurses for Healthy Environments (ANHE). At the national level, I am an active member of the National Association of School Nurses' Diversity, Equity and Inclusion Working Group and reappointed to the Diversity Leadership Committee of the American Heart Association for another term.

Describe any experiences you have had with public speaking, working with the media, working with legislators, and/or testifying in the legislature or other policy-making governmental bodies.

Advocacy is a pillar of nursing, and we know that when nurses speak, our legislators listen! I first testified in Washington DC on behalf of the Alliance of Nurses for Healthy Environments back in 2016, and have since taken every opportunity to speak up on behalf of nursing and address issues that impact my current practice and public health.

I have completed numerous interviews with the media-including podcasts, news articles, and interviews. I have completed media training, and seek other professional growth opportunities related to working with the media. During my leadership as President, IASN began working with Capitol Edge Consulting and worked towards legislation for a school nurse capacity study, ultimately leading to its Inaugural School Nurse Lobby Day this past May.

I most recently attended ANA Hill Day in June, joining over 400 nurses from across the country whom sought support for four of ANA's key federal policy issues: addressing the nurse staffing crisis; removing barriers to APRN full practice authority; building and sustaining the nursing workforce; and understanding the value of nurses and healthcare burnout.

I encourage every nurse reading this to please stay up to date on exactly what ANA and ANA-Illinois is doing to help advance the cause of nursing at the national and state level. Describe a situation where you influenced others to take action within your workplace, your community, or in a professional nursing organization.

I have demonstrated positive influence within the specialty of school nursing locally, regionally, and nationally. As an innovative leader, I have made positive changes to elevate the Illinois Association of School Nurses, and positively influence its members and stakeholders.

During my Presidency, I was the voice of school nurses in Illinois and provided many opportunities for IASN members to amplify their own voice and leadership. I promoted wellness and educational success of school communities by supporting, developing and advocating for all professional school nurse leaders. I was the creator of the successful, and still running, IASN Town Hall Meetings to educate school nurses on relevant topics impacting their roles. I strengthened collaborative relationships between IASN and stakeholders, like the Illinois Chapter of the American Academy of Pediatrics. I led the development of a School Nurse Toolkit on Vaccine with the ICAAP and created fundraising opportunities by creating an IASN store front, and promoting IASN gear to members.

I increased the visibility of IASN by creating an Instagram and Twitter that now has a massive following. I believe that all students have a right to have their physical and mental health needs safely met while in the school setting, no matter their zip code. At IASN, I spearheaded the work to promote legislation to appropriate funding for a school nurse capacity study since January 2022 and ignited the idea for the Inaugural Annual School Nurse Lobby Day that came to fruition in 2023. I have testified in Springfield and in front of the Illinois State Board of Education on the nursing shortage and its impact on the specialty of school nursing, making it clear that the data collected from a school nurse capacity study would help drive action for our work in optimizing student health and learning for the future. The influence I've generated behind HB5601 and HR817 led to the Illinois State Board of Education allocating a school nurse capacity study and provide funding of \$350,000. At the national level, I was honored with the National Association of School Nurses' President's Award for her work on the NASN's DEI Task Force. On the DEI Task Force, I advocated for a new DEI Leadership in School Nursing Award to recognize peers that may have been otherwise marginalized within the organization. I presented nationally on the legislative and advocacy work of IASN, and with the CDC on Infection Control and Prevention Guidelines for K-12 Schools. Furthermore, I have amplified my voice on various platforms as the expert in public health, most recently as the lead for Salud America's Twitter Chat on Mental Health Impacting Youth in the U.S.
