

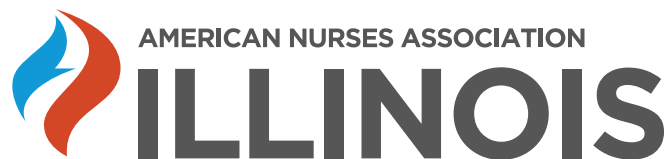

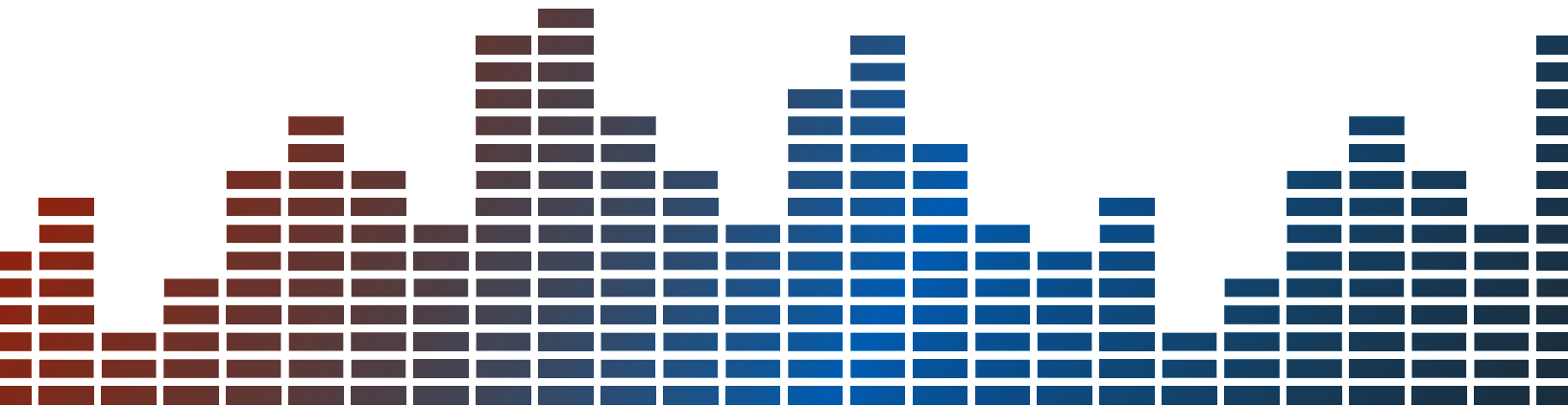

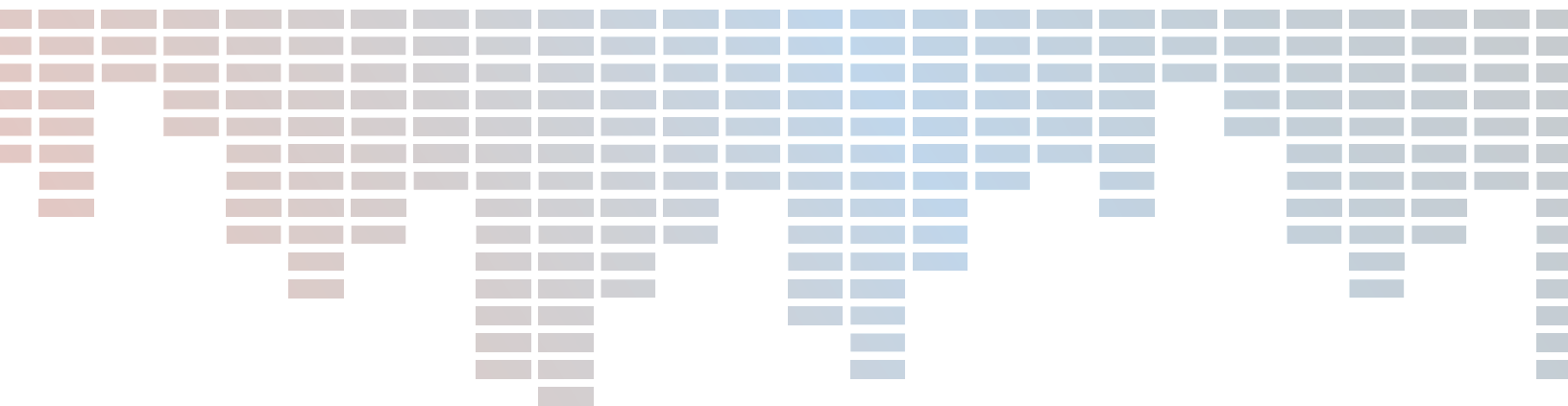


NURSING: THE FUTURE IS OURS!

Payment and Cancellation of Exhibit Space - Upon acceptance of this application by ANA-Illinois, it shall be a legally binding contract between the exhibitor and ANA-Illinois. Refunds will not be issued under any circumstances, regardless of the date of cancellation, unless ANA-Illinois cancels the contract, for reasons other than non-payment by the Exhibitor. ANA-Illinois will be entitled to retain or collect 100% of the Exhibitor's total contract obligation if the Exhibitor cancels or reduces their exhibit space.

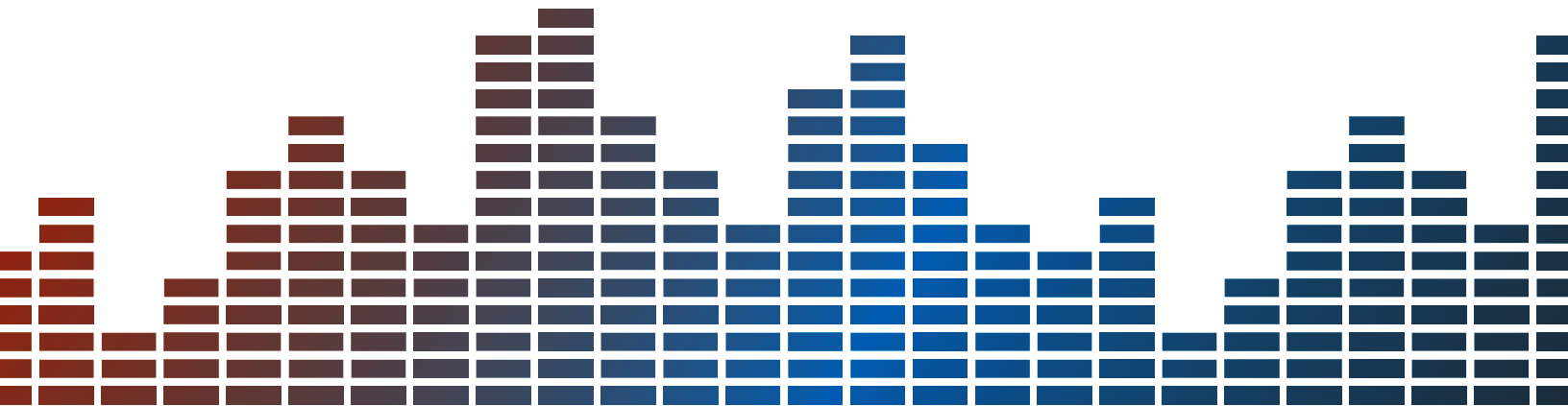
